1. Approval of Minutes of last meeting:

Generator funds \$116,902.00 from County and paid for it this year. Engineer services, three thousand for 2021. Contract with Wood Rodgers, thirty nine thousand has been spent. \$123,140.00, is the full Engineers contract.

Water line break, Art called AP Plumbing. Leo turned off water and turned water back on for repair. Generator was delivered last week. What is the wells location? Need to review contract with Landowner. May need a few more feet of space for location of generator. Add generator to insurance policy.
